Chairperson's Report

In the very challenging times of Covid-19 BIM has achieved much. The Committee of Management and staff at BIM have worked remotely since March 2020. DHHS provided additional core funding to cover the extra costs.

Bruce Francis was employed last year to manage a project to support people who wanted to give evidence to the *Royal Commission into Violence, Abuse, Neglect and Exploitation of People with Disability.* A number of BIM members gave evidence and BIM sent a submission to the Royal Commission this year. It was produced in consultation with many BIM members. A copy was sent to all BIM members and supporters.

Extra Covid specific funding came from the State and Federal governments. It was used to pay staff (Fiona, Yannick and Sally) to run weekly Zoom meetings to address social isolation and give information. The Monday Coffee meeting has run for the last six months and the Pilot Peer Support Group, 'BrainWave', has happened every Wednesday for the last two months. Both via Zoom online video. This has been hugely successful. These will continue with BIM members taking on the running of these events.

The one-year ILC project funded by the NDIA had five staff members in 2019-2020. Their work has increased the capacity of BIM exponentially. The details of that project are provided elsewhere in this Annual Report.

BIM has received another ILC grant for an 'Engage-Support-Link' project. It is a two-year project, under the Information Linkages and Capacity Building program. The current project staff Peter, Yannick, Fiona, Sally and Fraser will be continuing with BIM on this project. Also, an additional Peer Coordinator worker is joining the team in November 2020. The project will increase social engagement, information provision and personal and skills development with a larger and more widely dispersed group of people living with ABI across metropolitan and regional Victoria.

This year BIM

- produced a Strategic Direction for 2020-2022
- surveyed members for their input to the Strategic Direction
- surveyed members about their views and stories of abuse and discrimination;
 to include in BIMs submission to the Royal Commission into Disability.
- updated multiple polices included a comprehensive Risk Management Policy.

BIM expects to return to our office in Ross House in 2021 in a Covid safe way.

I'd like to thank and acknowledge all members of the Committee of Management for their work over the past year. Special thanks to Manda and Lisa who stepped down, Nia who has changed roles, James who has stepped in as Secretary and Col who has stepped up to Vice President. Continued thanks to Roger, Helen, Kelvin and Anat. Thank you too to Adrian for his work on the Newsletter, Lara for her work on the ABI Wise App and Col for his work on the website and Facebook.

Treasurers Report For Financial Year Ending 30th June 2020

Firstly, what a year it has been for all of us at Brain Injury Matters. It has been a year of unforeseen circumstances where both income and expenses varied.

With some sadness and trepidation, we all were wondering what was going to happen after we were unsuccessful in our application last year for 3 years of funding worth >\$1m which we covered at our last AGM. However, we learnt a lot through this process and used these learnings to be successful at another round of grants. Forecasting change became a little difficult albeit we have ended the financial year in a strong position.

- For the 12 months ending 30th June 2020 we ended with \$187,447 held in our accounts.
- Our financials were audited by Collins & Co (as attached at the end of this document) at a cost of \$1,925.
- Operating expenses increased by \$118,895 (101.3%) from the previous year.
 This is due to increased wage costs & associated costs due to successful
 projects receiving funding, Covid 19 (Income / Expenses) and day to day
 workflow requirements.
- Income however also increased (Accruals Basis) by 301.9% from the previous year by \$174,734 mainly due to funding from the Information Linkages & Capacity Building Grant (ILC) and cash flow boosts from the government in response to Covid 19.

Another contributor to this increase in income was an amount of \$21,751 received on 19th June 2020 to assist us to meet rising demand for self-advocacy as a result of Covid-19. This was provided by Luke Donnellan, the Minister assisting the DHHS.

These funds assisted all of us to "Work from Home" and continue "Business as Usual" with additional costs being met such as:

- Printer \$48
- Stationery \$56
- Cleaning of office \$500
- Masks & Sanitiser supplies \$500
- Website Consumables \$250
- Zoom Rental \$144 (Six months for July to December)
- BIM Mobile \$270 (Six months for July to December)
- Home Allowance \$1,484 (Four Months for August to November)
- Funding Extra Hours for 2 employees \$3,393 (Four Months for August to November, assumes 3 extra hours a week each)
- Extension of project staff & ILC Project \$14,187 (1 Month, November)
- Survey Monkey \$384

- Postage \$535
- Total Costs = \$21.751

These funds were a welcome relief as we would have had to fund these from our existing core account balances.

- The ATO (Australian Taxation Office also provided funding (to help with Covid 19) totalling \$15,460. Notwithstanding we will receive an additional \$5,460 in October 2020.
- Expenses albeit somewhat unplanned for such as Telephone, Internet and General Expenses to facilitate "Working from Home" increased. These were funded though by the additional support measures from both DHHS and the ATO.
- Rental expenses were in line with forecast. Unfortunately, even though we
 cannot be in the office, expenses for Ross House continue and they too like
 other businesses have seen an income reduction. As we did not suffer like
 other businesses within the building, we did not proceed with seeking "rental
 relief".

Forecast

As previously indicated, we gained a lot of learnings from missing out on the \$1m grant (2 below) we were after at our last AGM. However, this has enabled us to ensure we were better armed for future opportunities with the last (3 below) coming to fruition:

- **1. Community Inclusion Capacity Development Program 2019-2020** \$218,000. 15 months, Commenced August 2019, concludes October 2020
- 2. Individual capacity Building program Grant opportunity 2019-2020 Unsuccessful bid for \$1M 3-year program
- 3. Information, Linkages and Capacity Building Individual Capacity Building 2020-2021

Successful \$500,000 - 2-year program

We know that we will continue to have a certain future with the last project for the next 2 years and will continue to manage costs and deliver on project outcomes in a stronger position. Unlike previous periods, rental has been included in this funding which was not in the past. Rental was a cost which drained our core monies each month as these were not covered by AMIDA/SARU funding which paid for a significant percentage of our Coordination and Support Worker's wages.

Information Technology Report

BIM Web Site

The IT subcommittee have been holding regular meetings with Amala, the very adept IT Masters student from Deakin University (Via A.N.D.) who has been very busy redeveloping the BIM web site over the previous couple of months (alongside her studies).

The web site is looking very professional with new features such as:

- BIM corporate colour scheme
- Accessibility feature which allows visitors to view the site with the own viewing preferences
- A very clean interface and a fresh new appearance
- Many new pages and menus making it much easier to navigate
- Links page to be more structured
- A history of the BIM app ABI Wise development is being considered for the site
- Also viewable, will be BIM's 4 policies including, Anti-Discrimination, Privacy, Bullying and Sexual Harassment as a matter of transparency
- New services and support page to provide information on where to get help

The Year of Zoom

2020 has been a particularly trying time for everyone considering the situation, we have found ourselves in with the virus and this comes as an exceptionally trying time for the not-for-profit sector. And with the many meetings that we have, monthly committee and executive meetings, these have all been migrated to online as have our new coffee mornings. And these would not have gone ahead except through the efforts of Yannick and other BIM members working out how to conduct the meetings via Zoom, something that a lot of people have now discovered.

The Victorian ABI Support Network Project

The Victorian ABI Support Network Project began in August 2019 and was implemented under the direction of a consortium comprised of Brain Injury Matters (BIM), United Brains and By Accident. The project was funded by the NDIS under its Information Linkages and Capacity Building (ILC) Program, for 12-months. This ILC program sought to enhance capacity of individual people with a disability and the organisational capacity of Disability Peoples Organisations.

Some of the key results from the Victorian ABI Support Network project are the:

- delivery of self-development training to 26 people with an ABI
- delivery of a range of organisational capacity building training attended by 43 participants on governance, financial literacy, risk management and employment practices
- development and implementation of a 2-year BIM Strategic Direction
- development of new or updating existing BIM policies
- conducting a needs survey of all BIM members
- locating existing and developing new resources to support peer support groups
- development and/or consolidation of internal organisational systems including finances, and membership
- employment of two people with an ABI, with support of a dedicated support
 worker. Further, the self-development training was developed and delivered
 by Eva Sifis, the founder of By Accident, herself a woman with lived
 experience of acquired brain injury.
- establishment of links with the key rehabilitation centres and hospitals where people with ABI undertake their rehabilitation

This project, like every part of the Victorian and Australian community has had to deal with the impact of the COVID-19 pandemic. COVID-19 has magnified the isolation and other challenges associated with having an acquired brain injury.

Though adopted by necessity, the delivery of training by ZOOM, has demonstrated that technology can assist in reaching and connecting with people, who otherwise may have remained isolated, and/or have not been previously connected with peers.

The no-cost extension (till 31 October 2020) of the project granted by the NDIS towards the end of the financial year, in recognition of the impact of the pandemic, has consolidated some of the connections established with people with an ABI who have been part of the self-development training.

These additional activities include a weekly social coffee morning attended by an average of 15 people, and a more structured group of 8 to 10 people. The Brain Injury Matters website is also being revamped during this project extension, seeking

to update and extend its information, promoting the importance of the lived experience.

Importantly for self-advocacy organisations led and run by people with a disability, the strengthening of the mechanisms to meaningfully involve people with an ABI in the project and in their organisations, is a central focus of the project. An example was the Brain Injury Matters Needs Survey getting the views of people with an ABI on key issues they confronted, to inform the new BIM Strategic Direction. BIM has decided that it will conduct this survey every year. The involvement of many people who previously had no connection with self-advocacy groups and the strong endorsement of the training, has meant a decrease in the social isolation, increased skills and confidence, leading to more control of their lives.

Note 1. Statement of Significant Accounting Policies

This financial report includes the financial statements and notes of Brain Injury Matters Incorporated, an incorporated association, which is incorporated in Victoria under the Associations Incorporation Reform Act 2012.

Basis of preparation

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the *Australian Charities and Not for Profits Commission Act* 2012 and the *Associations Incorporation Reform Act* 2012 (Victoria). The board has determined that the association is not a reporting entity.

The financial report has been prepared on an accruals basis and is based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

The following is a summary of the material accounting policies adopted by the company in the preparation of the general purpose financial report. The accounting policies have been consistently applied, unless otherwise stated.

Accounting Policies

a. Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities on the balance sheet.

b. Revenue

Revenue is measured at the fair value of the consideration received or receivable.

Grants are recognised at fair value where there is reasonable assurance that the grant will be received and all grant conditions will be met. Grants relating to expense items are recognised as income over the periods necessary to match the grant to the costs they are compensating.

Grants received for specific programs are recognised as income only to the extent of work completed on those projects when the terms of the grants stipulate that any unexpended funds are to be returned to the sponsor if the program is not completed. In those circumstances the funds attributable to work still to be completed are carried forward as grants income deferred.

Revenue from the sale of goods is recognised at the point of delivery as this corresponds to the transfer of significant risks and rewards of ownership of the goods and the cessation of all involvement in those goods.

Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets.

Revenue from the rendering of a service is recognised upon the delivery of the service to the customers.

Note 1. Statement of Significant Accounting Policies (continued)

c. Income Tax

By virtue of its aims as set out in the constitution, the Association qualifies as an organisation specifically exempt from income tax under the *Income Tax Assessment Act 1997*.

d. Goods and Services Tax (GST)

Revenues, expenses and assets are recognised gross of the amount of GST

e. Provisions

Provisions are recognised when the Association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

Note 2. Grants Received in Advance

Grants received for specific programs are recognised as income only to the extent of work completed on those projects when the terms of the grants stipulate that any unexpended funds are to be returned to the funder/grantor if the program is not completed. In those circumstances the funds attributable to work still to be completed are carried forward as grants income deferred.

Opinion

Basis for Opinion
